Fund Objective

The objective of the portfolio is to provide investors with a moderate long term total return.

Fund Strategy

Investments to be included in the portfolio will, apart from assets in liquid form, consist solely of participatory interests in portfolios of collective investment schemes registered in the Republic of South Africa. The portfolio will consist of a mix of collective investment scheme portfolios investing in equity, bonds and property and money market instruments. The portfolio's equity exposure will range between 0% and 75% of the portfolio's net asset value. The Fund is Regulation 28 compliant. The portfolio will also be allowed to invest in listed and unlisted financial instruments (derivatives) as allowed by the Act from time to time. The Manager shall be permitted to invest on behalf of the portfolio in offshore investments as legislation permits.

Total Expense Ratio (TER) is the percentage value of the Financial Product that was incurred as expenses relating to the administration of the Financial Product. Total Investment Charges (TER + TC) is the total percentage value of the Financial Product that was incurred as costs relating to the investment of the Financial Product.

The historic total TER above is calculated based on 3 years of historic data, and includes Performance Fees until 30 June 2020. No performance fees have been charged since 1 July 2020 so the historic total TER will fall into line with the current effective TER as the historic data is removed from the calculation over time.

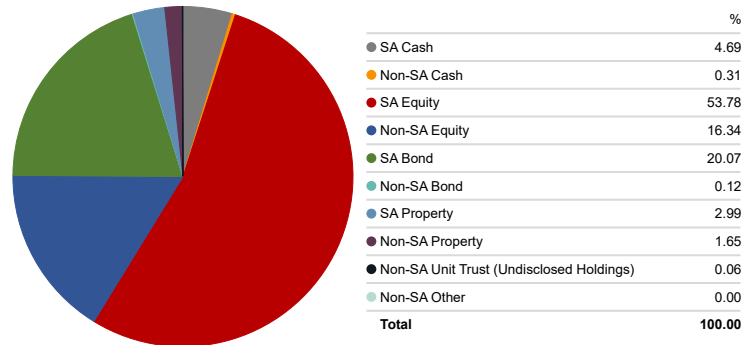

Risk Profile

Moderate Aggressive

Your primary aim is to achieve the required capital growth necessary to realise your long-term goals and objectives. You are prepared to tolerate fluctuations in your returns because you know that the longer-term picture is worth the short term pain, even if that means you lose money sometimes. While diversified across all the major asset classes, your portfolio will be tilted more towards equities because you know they offer the best long-term returns of all the asset classes and thus your wealth will grow over time.

Glossary Terms

Annualised Returns

Annualised return is the weighted average compound growth rate over the period measured.

Asset Allocation

Asset allocation is the percentage holding in different asset classes (i.e. equities, bonds, property, etc.). It is used to determine the level of diversification in a portfolio.

Capital Volatility

Volatility is a measure of 'risk' and refers to the extent to which the price of an investment or capital value fluctuates over a certain period of time. Funds with high volatility usually offer the potential for higher returns over the longer term than low volatility funds.

Cumulative Returns

Cumulative return is the total growth experienced over the period measured.

Derivatives

Derivatives are instruments generally used as an instrument to protect against risk (capital losses), but can also be used for speculative purposes. Examples are futures, options and swaps.

Distributions

The income that is generated from an investment and given to investors through monthly, quarterly, biannual or annual distribution pay-outs.

Diversification

This is a strategy designed to reduce risk within a portfolio by combining a variety of investments (or asset classes) such as equities, bonds, cash or property, which are unlikely to all move in the same direction at the same time. This is designed to reduce the risk (and protect against capital losses) within a portfolio. Diversification allows for more consistent performance under a wide range of economic conditions as it smoothes out the impact of negative market events. The positive performance of some investments or asset classes should neutralize the negative performance of others.

Financial Instruments

Derivatives also known as financial instruments (such as a future, option, or warrants) whose value derives from and is dependent on the change in value of an underlying asset (such as a commodity, currency, or security) to protect against risk (capital losses).

Fund Objective

The fund objective is the portfolio's core goal.

Fund Strategy

The fund strategy is the way that the fund is managed to achieve the fund objective.

Information Ratio

The Information Ratio measures the market risk-adjusted performance of an investment or portfolio. The greater a portfolio's Information Ratio, the better its risk-adjusted performance has been compared to the market in general.

Collective Investment Schemes

Collective Investment Schemes (CIS) (also called unit trusts) are portfolios of assets such as equities, bonds, cash and listed property, in which investors can buy units. They allow private investors to pool their money together into a single fund, thus spreading their risk across a range of investments, getting the benefit of professional fund management, and reducing their costs.

LISP (Linked Investment Service Provider)

A Linked Investment Service Provider is a financial institution which packages, distributes and administers a broad range of unit trust investments.

Market Capitalization

Market capitalization is the total value of the issued shares of a publicly traded company; it is calculated by multiplying the share price by the number of shares in issue.

Maximum Drawdown

The maximum drawdown measures the highest peak to trough loss experienced by the fund.

Participatory Interests

When you buy a unit trust, your money is pooled with that of many other investors. The total value of the pool of invested money in a unit trust fund is split into equal portions called participatory interests or units. When you invest your money in a unit trust, you buy a portion of the participatory interests in the total unit trust portfolio. Participatory interests are therefore the number of units that you have in a particular unit trust portfolio.

Sharpe Ratio

The Sharpe Ratio measures total risk-adjusted performance of an investment or portfolio. It measures the amount of risk associated with the returns generated by the portfolio and indicates whether a portfolio's returns are due to excessive risk or not. The greater a portfolio's Sharpe ratio, the better its risk-adjusted performance has been (i.e. a higher return with a contained risk profile, where the portfolio manager is not taking excessive risk to achieve those returns).

Standard Deviation

The standard deviation is a widely used risk measure of the return dispersion relative to the mean. It is also referred to as volatility.

Portfolio Manager Comment

Cinnabar Market Update: May 2023

SA Market Drivers

Despite local inflation data surprising to the downside (6.8% vs. 7% expected), the SARB was left with little choice but to raise the Repo rate by 0.5% in response to the sharp weakness of the ZAR and other major central banks also hiking the interest rates. The SARB has indicated that they are likely to hike rates further if deemed necessary in the face of inflationary pressures and currency weakness.

Earnings announcements and trading updates from Spar, Tiger Brands and Pick 'n Pay over the month laid to bare the difficult trading environment these companies are going through in SA. Earnings were beaten up as consumers reined their budgets and costs (particularly those to generate their own electricity) skyrocketed. The month saw their respective market values fall by roughly 25% showing the markets displeasure and the environment within which these announcements were made.

Geopolitical tensions surrounding South Africa were raised as the country's neutrality in the Russia-Ukraine war and their general pro-Moscow stance were called into question on the back of the Lady R saga still unfolding. This raised fears of possible sanctions and risks to trading ties with the country's main trading partners. Foreign investors' appetite towards local equities, bonds and the currency soured materially due to the news.

Global Market Drivers

The debt ceiling stand-off dominated US market news but also caused global concern. However, as the deadline to avoid default loomed, a deal was reached to suspend the debt ceiling until 2025. This was agreed by both houses and signed into law in early June, averting a US debt default that could have rocked financial markets.

US Inflation fell slightly to 4.9% in April from 5% in March, and core inflation also decreased to 5.5% from 5.6% in March (largely in line with expectations). Labour market indicators showed strength, with 253,000 new jobs created and unemployment dropping to 3.4% in April from 3.5% in March.

Japan continued to garner investor interest as preliminary Q1 quarter-on-quarter GDP growth was recorded at 0.4%, above consensus of 0.1%. Inflation nudged up again (to 3.5% in April), and core inflation rose to 3.4% providing optimism that Japan might finally be able to generate some inflation, having been stuck with low to no inflation over the last 25 years.

Economic data out of China continued to disappoint with inflation coming out at near zero and imports plunging 7.9% over the year suggesting mute domestic demand. Industrial production was recorded at 5.6% in April (almost half of the expectation of 10.9%).

The concentrated nature of returns on the market became starkly apparent in May when one of the largest companies in the world, Nvidia, surprised the market with positive earnings resulting in the stock returning 36% (in USD) in the month. Tesla was also up 24% in May.
