Fund Objective

The objective of the fund is to provide investors with a moderate long term total return.

Fund Strategy

The fund will consist of a mix of collective investment scheme portfolios investing in equity, bonds and property and money market instruments. The fund's equity exposure will range between 0% and 75% of the portfolio's net asset value. The fund is managed in accordance with regulations governing pension funds and may hold up to 45% in foreign assets. The fund will also be allowed to invest in listed and unlisted financial instruments (derivatives) for the sole purpose of hedging exchange rate risk.

Total Expense Ratio (TER) is the percentage value of the Financial Product that was incurred as expenses relating to the administration of the Financial Product. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's.

Transaction Cost (TC) is the percentage value of the Financial Product that was incurred as costs relating to the buying and selling of the assets underlying the Financial Product. Transaction Costs are a necessary cost in administering the Financial Product and impacts Financial Product returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Financial Product, the investment decisions of the investment manager and the TER.

Total Investment Charges (TER + TC) is the total percentage value of the Financial Product that was incurred as costs relating to the investment of the Financial Product.

The historic total TER above is calculated based on 3 years of historic data, and includes Performance Fees until 30 June 2020. No performance fees have been charged since 1 July 2020 so the historic total TER will fall into line with the current effective TER as the historic data is removed from the calculation over time.

Effective 1 April 2026, the administration fee applicable to retail clients with an investment balance below R50,000 will increase from R23 to R57.50 (VAT inclusive). Clients with an active recurring monthly debit order will not be levied this fee.

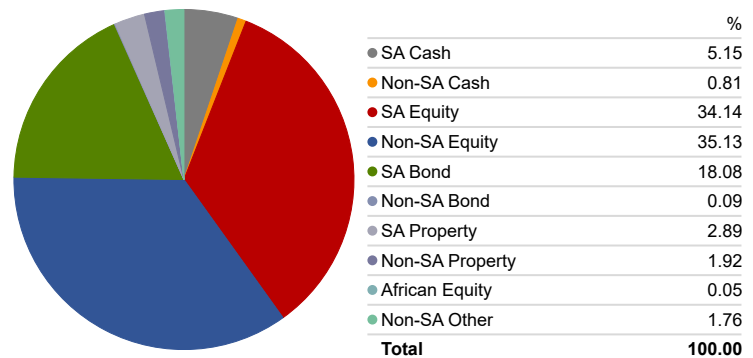

Portfolio Manager Comment

Cinnabar Market Update: April 2026

Local Markets (South Africa)

Closer to home, April was a month of cautious recovery. The JSE climbed back from near 111,000 points to around 119,000 as global sentiment improved, while the rand continued to trade under pressure near R17 to the dollar amid elevated oil prices and a stronger US currency. The South African Reserve Bank, much like its global counterparts, held interest rates steady at 6.75% — acknowledging that inflation is expected to rise this year, while still projecting that rate cuts could come towards the end of 2026 if conditions allow. South African assets have so far shown relative resilience, supported by improved macroeconomic fundamentals, which has helped cushion the blow from global volatility. The key question going forward is how much of the oil price shock still has to filter through — and our Investor Insight below unpacks exactly why that lag matters.

Global Drivers

April turned out to be a surprisingly strong month for global markets, despite plenty of noise in the headlines. Ongoing conflict in the Middle East kept oil prices elevated — Brent crude pushed above \$110 per barrel by month-end — but investors largely looked past the tension and focused on what really drove the month: a powerful comeback in technology stocks. The S&P 500 and Nasdaq both hit all-time highs, and the MSCI Emerging Markets Index was the standout performer, gaining nearly 15%, powered by extraordinary gains in Taiwan and South Korea. Beneath the surface, though, central banks were sending a more cautious message. The US Federal Reserve held rates steady, noting that inflation is elevated in part due to the rise in global energy prices, while the Bank of Japan also held at 0.75%, sharply raising its inflation forecast to 2.8% for 2026. The world's major central banks are in a holding pattern — not panicking, but aware that the full effects of higher oil prices haven't yet worked their way through to everyday prices. That ripple effect is something investors should keep a close eye on in the months ahead.

Risk Profile

Glossary Terms

Annualised Returns

Annualised return is the weighted average compound growth rate over the period measured.

Asset Allocation

Asset allocation is the percentage holding in different asset classes (i.e. equities, bonds, property, etc.). It is used to determine the level of diversification in a portfolio.

Capital Volatility

Volatility is a measure of 'risk' and refers to the extent to which the price of an investment or capital value fluctuates over a certain period of time. Funds with high volatility usually offer the potential for higher returns over the longer term than low volatility funds.

Cumulative Returns

Cumulative return is the total growth experienced over the period measured.

Derivatives

Derivatives are instruments generally used as an instrument to protect against risk (capital losses), but can also be used for speculative purposes. Examples are futures, options and swaps.

Distributions

The income that is generated from an investment and given to investors through monthly, quarterly, biannual or annual distribution pay-outs.

Diversification

This is a strategy designed to reduce risk within a portfolio by combining a variety of investments (or asset classes) such as equities, bonds, cash or property, which are unlikely to all move in the same direction at the same time. This is designed to reduce the risk (and protect against capital losses) within a portfolio. Diversification allows for more consistent performance under a wide range of economic conditions as it smoothes out the impact of negative market events. The positive performance of some investments or asset classes should neutralize the negative performance of others.

Financial Instruments

Derivatives also known as financial instruments (such as a future, option, or warrants) whose value derives from and is dependent on the change in value of an underlying asset (such as a commodity, currency, or security) to protect against risk (capital losses).

Fund Objective

The fund objective is the portfolio's core goal.

Fund Strategy

The fund strategy is the way that the fund is managed to achieve the fund objective.

Information Ratio

The Information Ratio measures the market risk-adjusted performance of an investment or portfolio. The greater a portfolio's Information Ratio, the better its risk-adjusted performance has been compared to the market in general.

Collective Investment Schemes

Collective Investment Schemes (CIS) (also called unit trusts) are portfolios of assets such as equities, bonds, cash and listed property, in which investors can buy units. They allow private investors to pool their money together into a single fund, thus spreading their risk across a range of investments, getting the benefit of professional fund management, and reducing their costs.

LISP (Linked Investment Service Provider)

A Linked Investment Service Provider is a financial institution which packages, distributes and administers a broad range of unit trust investments.

Market Capitalization

Market capitalization is the total value of the issued shares of a publicly traded company; it is calculated by multiplying the share price by the number of shares in issue.

Maximum Drawdown

The maximum drawdown measures the highest peak to trough loss experienced by the fund.

Participatory Interests

When you buy a unit trust, your money is pooled with that of many other investors. The total value of the pool of invested money in a unit trust fund is split into equal portions called participatory interests or units. When you invest your money in a unit trust, you buy a portion of the participatory interests in the total unit trust portfolio. Participatory interests are therefore the number of units that you have in a particular unit trust portfolio.

Sharpe Ratio

The Sharpe Ratio measures total risk-adjusted performance of an investment or portfolio. It measures the amount of risk associated with the returns generated by the portfolio and indicates whether a portfolio's returns are due to excessive risk or not. The greater a portfolio's Sharpe ratio, the better its risk-adjusted performance has been (i.e. a higher return with a contained risk profile, where the portfolio manager is not taking excessive risk to achieve those returns).

Standard Deviation

The standard deviation is a widely used risk measure of the return dispersion relative to the mean. It is also referred to as volatility.
