### Fund Objective

The objective of the fund is to provide investors with a moderate to high level of income and stable capital growth.

### Fund Strategy

The fund will consist of a mix of collective investment scheme portfolios investing in equity, bonds, property and money market instruments. The fund's equity exposure will range between 0% and 40% of the portfolio's net asset value. The fund will be managed in accordance with regulations governing pensions funds and may hold up to 45% in foreign assets. The fund will also be allowed to invest in listed and unlisted financial instruments (derivatives) for the sole purpose of hedging exchange rate risk.

Total Expense Ratio (TER) is the percentage value of the Financial Product that was incurred as expenses relating to the administration of the Financial Product. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's.

Transaction Cost (TC) is the percentage value of the Financial Product that was incurred as costs relating to the buying and selling of the assets underlying the Financial Product. Transaction Costs are a necessary cost in administering the Financial Product and impacts Financial Product returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Financial Product, the investment decisions of the investment manager and the TER.

Total Investment Charges (TER + TC) is the total percentage value of the Financial Product that was incurred as costs relating to the investment of the Financial Product.

The historic total TER above is calculated based on 3 years of historic data, and includes Performance Fees until 30 June 2020. No performance fees have been charged since 1 July 2020 so the historic total TER will fall into line with the current effective TER as the historic data is removed from the calculation over time.

Effective 1 April 2026, the administration fee applicable to retail clients with an investment balance below R50,000 will increase from R23 to R57.50 (VAT inclusive). Clients with an active recurring monthly debit order will not be levied this fee.

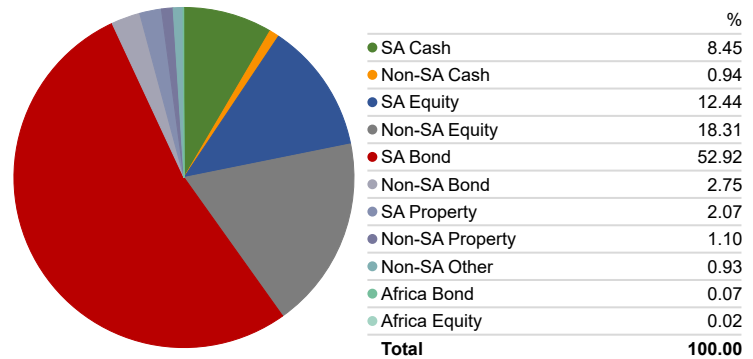

### Portfolio Manager Comment

Cinnabar Market Update: June 2026

#### Local Markets (South Africa)

June brought a pause in the AI-fuelled rally that powered markets through April and May. The S&P 500 snapped a two-month winning streak, falling about 1% for the month, as investors grew cautious about whether the previous AI rally had run too far too fast. The Nasdaq fell 2.8%, weighed down by sharp declines in some of its biggest constituents, with Microsoft falling 17% and Oracle dropping 35% in their worst months in decades. The Dow, by contrast, gained 2.5% as investors rotated out of technology and into financials, healthcare and industrials. Despite the June pullback, the broader picture remains healthy: the S&P 500 and Nasdaq have surged around 15% and 21% respectively since the end of March, their best quarter in six years. On the interest rate front, the Federal Reserve is now expected to remain on hold through 2026 and potentially into 2027, with persistent inflation keeping any cuts firmly off the table for now. The month was a timely reminder that markets don't move in a straight line, particularly when valuations have stretched as far as they have in the technology sector.

#### Global Drivers

June was an encouraging month for South Africa, with the country's improving fundamentals finally receiving some formal recognition. Fitch Ratings upgraded South Africa's long-term credit rating from BB- to BB, the agency's first upgrade for the country in almost 21 years, citing prudent fiscal management and sustained primary budget surpluses. The upgrade is especially notable given that five investment-grade sovereigns received negative rating actions from Fitch over the same period, making South Africa one of very few countries bucking the global trend. On inflation, May's inflation data came in below forecast, which analysts said reduced the likelihood of another interest rate hike at the SARB's next meeting. May inflation rose to 4.5%, still elevated but slightly softer than feared, offering some relief after April's sharp jump. The overall local picture is one of gradual stabilisation: inflation is elevated but not spiralling, the rand has proven resilient, growth continues to tick along, and the country's fiscal credibility is improving. For South African investors, June was a month to feel quietly optimistic.

### Risk Profile

#### Moderate Conservative

You are cautious about taking on risk (i.e. have a limited exposure to equities in your portfolio). You want your capital to be safe and prefer fairly stable income and/or income growth. ### Glossary Terms

#### Annualised Returns

Annualised return is the weighted average compound growth rate over the period measured.

#### Asset Allocation

Asset allocation is the percentage holding in different asset classes (i.e. equities, bonds, property, etc.). It is used to determine the level of diversification in a portfolio.

#### Capital Volatility

Volatility is a measure of 'risk' and refers to the extent to which the price of an investment or capital value fluctuates over a certain period of time. Funds with high volatility usually offer the potential for higher returns over the longer term than low volatility funds.

#### Cumulative Returns

Cumulative return is the total growth experienced over the period measured.

#### Derivatives

Derivatives are instruments generally used as an instrument to protect against risk (capital losses), but can also be used for speculative purposes. Examples are futures, options and swaps.

#### Distributions

The income that is generated from an investment and given to investors through monthly, quarterly, biannual or annual distribution pay-outs.

#### Diversification

This is a strategy designed to reduce risk within a portfolio by combining a variety of investments (or asset classes) such as equities, bonds, cash or property, which are unlikely to all move in the same direction at the same time. This is designed to reduce the risk (and protect against capital losses) within a portfolio. Diversification allows for more consistent performance under a wide range of economic conditions as it smoothes out the impact of negative market events. The positive performance of some investments or asset classes should neutralize the negative performance of others.

#### Financial Instruments

Derivatives also known as financial instruments (such as a future, option, or warrants) whose value derives from and is dependent on the change in value of an underlying asset (such as a commodity, currency, or security) to protect against risk (capital losses).

#### Fund Objective

The fund objective is the portfolio's core goal.

#### Fund Strategy

The fund strategy is the way that the fund is managed to achieve the fund objective.

#### Information Ratio

The Information Ratio measures the market risk-adjusted performance of an investment or portfolio. The greater a portfolio's Information Ratio, the better its risk-adjusted performance has been compared to the market in general.

#### Collective Investment Schemes

Collective Investment Schemes (CIS) (also called unit trusts) are portfolios of assets such as equities, bonds, cash and listed property, in which investors can buy units. They allow private investors to pool their money together into a single fund, thus spreading their risk across a range of investments, getting the benefit of professional fund management, and reducing their costs.

#### LISP (Linked Investment Service Provider)

A Linked Investment Service Provider is a financial institution which packages, distributes and administers a broad range of unit trust investments.

#### Market Capitalization

Market capitalization is the total value of the issued shares of a publicly traded company; it is calculated by multiplying the share price by the number of shares in issue.

#### Maximum Drawdown

The maximum drawdown measures the highest peak to trough loss experienced by the fund.

#### Participatory Interests

When you buy a unit trust, your money is pooled with that of many other investors. The total value of the pool of risk associated with the returns generated by the portfolio and indicates whether a portfolio's returns are due to excessive risk or not. The greater a portfolio's Sharpe ratio, the better its risk-adjusted performance has been (i.e. a higher return with a contained risk profile, where the portfolio manager is not taking excessive risk to achieve those returns).

#### Sharpe Ratio

The Sharpe Ratio measures total risk-adjusted performance of an investment or portfolio. It measures the amount of risk associated with the returns generated by the portfolio and indicates whether a portfolio's returns are due to excessive risk or not. The greater a portfolio's Sharpe ratio, the better its risk-adjusted performance has been (i.e. a higher return with a contained risk profile, where the portfolio manager is not taking excessive risk to achieve those returns).

#### Standard Deviation

The standard deviation is a widely used risk measure of the return dispersion relative to the mean. It is also referred to as volatility.
