Fund Objective

The objective of the fund is to provide investors with low volatility moderate long term capital growth.

Fund Strategy

The fund will consist of a mix of collective investment scheme portfolios investing in equity, bonds and property and money market instruments. The fund's net equity exposure will range between 0% and 60% of the portfolio's net asset value. The fund is managed in accordance with regulations governing pension funds and may hold up to 45% in foreign assets. The fund will also be allowed to invest in listed and unlisted financial instruments (derivatives) for the sole purpose of hedging exchange rate risk.

Total Expense Ratio (TER) is the percentage value of the Financial Product that was incurred as expenses relating to the administration of the Financial Product. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's.

Transaction Cost (TC) is the percentage value of the Financial Product that was incurred as costs relating to the buying and selling of the assets underlying the Financial Product. Transaction Costs are a necessary cost in administering the Financial Product and impacts Financial Product returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Financial Product, the investment decisions of the investment manager and the TER.

Total Investment Charges (TER + TC) is the total percentage value of the Financial Product that was incurred as costs relating to the investment of the Financial Product.

The historic total TER above is calculated based on 3 years of historic data, and includes Performance Fees until 30 June 2020. No performance fees have been charged since 1 July 2020 so the historic total TER will fall into line with the current effective TER as the historic data is removed from the calculation over time.

Effective 1 April 2026, the administration fee applicable to retail clients with an investment balance below R50,000 will increase from R23 to R57.50 (VAT inclusive). Clients with an active recurring monthly debit order will not be levied this fee.

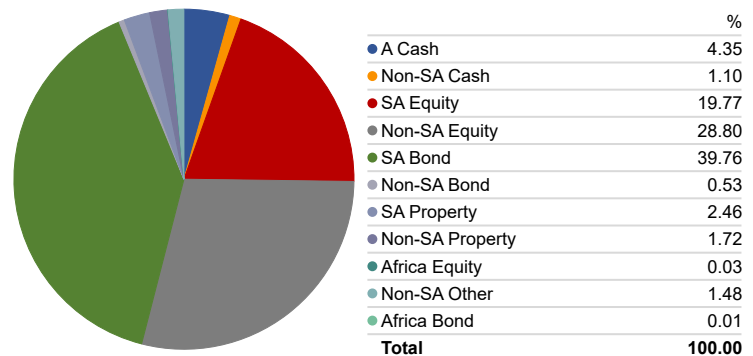

Portfolio Manager Commentary

Cinnabar Market Update: July 2026

Local Markets (South Africa)

South Africa delivered a genuine surprise in July. The SARB defied expectations by holding rates steady at 7%, when 17 of the 20 economists surveyed by Bloomberg had expected a 25 basis point hike. Four MPC members backed the hold while two favoured an increase. Governor Kganyago cited a slightly improved inflation outlook and weak growth as the reason for the pause, and the central bank revised its 2026 inflation forecast lower to 4% from 4.4% previously. The rand initially weakened sharply on the decision, briefly becoming the day's worst performing global currency, before stabilising as markets digested the reasoning. Local equities had a more constructive month, supported by the improved rate outlook and continued positive sentiment following the Fitch upgrade. On inflation, June's headline print came in at 5%, the fastest pace in two years, driven by continued fuel and food pressures. The picture locally is nuanced: inflation is still uncomfortably high, but the SARB is signalling confidence that it will come back down without needing to tighten further. For borrowers, this is welcome news, and it suggests the local rate hiking cycle may already be at its peak.

Global Drivers

July was a strong month for global equity markets, with earnings once again doing the heavy lifting. Corporate earnings for S&P 500 companies are expected to grow around 24% for 2026, and analysts are forecasting Q2 growth of 22% year-on-year, providing the fundamental backbone for continued market strength. The Nasdaq recovered from June's wobble as major technology names posted strong results, with Microsoft alone jumping 16% on the day it released Azure growth numbers that beat expectations. The Federal Reserve remained firmly in the spotlight. At its July meeting, the Fed voted 9-3 to hold rates steady at 3.5% to 3.75%, with three regional presidents dissenting in favour of a hike, the most dissents at a single meeting since 2016. New Fed Chair Kevin Warsh, presiding over only his second meeting, has argued for giving markets fewer signals about future policy, and the FOMC statement was notably shorter than usual as a result. The takeaway is that while the Fed is holding for now, there is a real internal debate about whether rates need to go higher to bring inflation back to target, and markets will be watching September's meeting closely.

Risk Profile

Moderate

You want to protect yourself from the ups and downs as much as possible and, in so doing, have as smooth a ride as is possible. But you know you need to take some risk to grow your capital. You have a medium to long-term investment horizon; you are looking for a diversified portfolio (ie, a portfolio that invests in a number of different asset classes to spread your risk), and one that offers real (after inflation) returns but with lower volatility. This fund would appeal to anyone nearing retirement (in the capital accumulation phase) and as well as after retirement (in the de-accumulation or capital preservation phase).

Glossary Terms

Annualised Returns

Annualised return is the weighted average compound growth rate over the period measured.

Asset Allocation

Asset allocation is the percentage holding in different asset classes (i.e. equities, bonds, property, etc.). It is used to determine the level of diversification in a portfolio.

Capital Volatility

Volatility is a measure of 'risk' and refers to the extent to which the price of an investment or capital value fluctuates over a certain period of time. Funds with high volatility usually offer the potential for higher returns over the longer term than low volatility funds.

Cumulative Returns

Cumulative return is the total growth experienced over the period measured.

Derivatives

Derivatives are instruments generally used as an instrument to protect against risk (capital losses), but can also be used for speculative purposes. Examples are futures, options and swaps.

Distributions

The income that is generated from an investment and given to investors through monthly, quarterly, biannual or annual distribution pay-outs.

Diversification

This is a strategy designed to reduce risk within a portfolio by combining a variety of investments (or asset classes) such as equities, bonds, cash or property, which are unlikely to all move in the same direction at the same time. This is designed to reduce the risk (and protect against capital losses) within a portfolio. Diversification allows for more consistent performance under a wide range of economic conditions as it smoothes out the impact of negative market events. The positive performance of some investments or asset classes should neutralize the negative performance of others.

Financial Instruments

Derivatives also known as financial instruments (such as a future, option, or warrants) whose value derives from and is dependent on the change in value of an underlying asset (such as a commodity, currency, or security) to protect against risk (capital losses).

Fund Objective

The fund objective is the portfolio's core goal.

Fund Strategy

The fund strategy is the way that the fund is managed to achieve the fund objective.

Information Ratio

The Information Ratio measures the market risk-adjusted performance of an investment or portfolio. The greater a portfolio's Information Ratio, the better its risk-adjusted performance has been compared to the market in general.

Collective Investment Schemes

Collective Investment Schemes (CIS) (also called unit trusts) are portfolios of assets such as equities, bonds, cash and listed property, in which investors can buy units. They allow private investors to pool their money together into a single fund, thus spreading their risk across a range of investments, getting the benefit of professional fund management, and reducing their costs.

LISP (Linked Investment Service Provider)

A Linked Investment Service Provider is a financial institution which packages, distributes and administers a broad range of unit trust investments.

Market Capitalization

Market capitalization is the total value of the issued shares of a publicly traded company; it is calculated by multiplying the share price by the number of shares in issue.

Maximum Drawdown

The maximum drawdown measures the highest peak to trough loss experienced by the fund.

Participatory Interests

When you buy a unit trust, your money is pooled with that of many other investors. The total value of the pool of invested money in a unit trust fund is split into equal portions called participatory interests or units. When you invest your money in a unit trust, you buy a portion of the participatory interests in the total unit trust portfolio. Participatory interests are therefore the number of units that you have in a particular unit trust portfolio.

Sharpe Ratio

The Sharpe Ratio measures total risk-adjusted performance of an investment or portfolio. It measures the amount of risk associated with the returns generated by the portfolio and indicates whether a portfolio's returns are due to excessive risk or not. The greater a portfolio's Sharpe ratio, the better its risk-adjusted performance has been (i.e. a higher return with a contained risk profile, where the portfolio manager is not taking excessive risk to achieve those returns).

Standard Deviation

The standard deviation is a widely used risk measure of the return dispersion relative to the mean. It is also referred to as volatility.
